Attachment A

Article V GOVERNING BOARD

Section 3: Official Actions – In order for the Board to take action, a majority of Board Members *present and voting* must support a position.

- A. The presiding officer may vote on all motions.
- B. Voting by proxy is not allowed.
- C. <u>A majority is determined only by affirmative and negative votes. An abstention is not a vote and does not count as a vote.</u>
- Section 4: Terms and Term Limits Each Member shall serve for a term of four (4) years. Newly elected Members will be seated after certification of the final election results, or in the event of a recount or election challenge, after confirmation of the results of that recount or election challenge, in which case incumbent Members will continue in their positions until any recount or election challenge is resolved.

Members elected or appointed to terms expiring in 2018 shall serve one additional year, and members elected or appointed to terms expiring in 2020 shall serve one additional year, due to a one-time extension of terms per City Council Ordinance. Beginning with election held in 2019, and each election thereafter, each and every Member shall be elected for a four (4) year term, or until a successor is elected or appointed.

Article VI OFFICERS

Section 3: Selection of Officers –

- B. Officers shall be elected bi-annually by the Board at the first meeting following an election for Members and every two years thereafter. Newly elected officers shall take office immediately upon election. Officers elected bi-annually by the Board in 2016 shall have a one-time, one-year term extension to coordinate officers' elections with the 2019 Neighborhood Council election.
- Section 4: Officer Terms Officers shall be elected for a two (2) year term and serve at the pleasure of the Board. Officers elected bi-annually by the Board in 2016 shall have a one-time, one-year term extension to coordinate officers' elections with the 2019 Neighborhood Council election.

Electric Vehicle Charging Stations Recommended Locations in Sherman Oaks With Amendments as Passed at the March 12, 2018 Board Meeting

- 1. EV Charging Plazas Recommending 2 stations with multiple connectors, serving a total of 8 parking spaces at each location.
 - a. Neighborhood EV Charging Plaza at Van Nuys/Sherman Oaks Park, in parking lot on Tyrone Avenue near Huston Street. This is city-owned property under the LA Department of Recreation and Parks. This site is recommended because it is located in an area with a high number of multi-family buildings adjacent to the park. This is a large parking lot which is lightly used on weekdays and weekends during the fall and winter months.
 - b. Commuter EV Charging Plaza at Fashion Square Mall in parking lot on Woodman Avenue. This property is privately owned by the Westfield Group. It is adjacent to 101 freeway with easy off and easy on access. This would make a great location for commuters who may need a quick charge or travelers passing through the area.
- 2. Malls and Shopping Centers Recommend adding charging stations at these shopping locations. The chargers should be located moderately away from the entrances so that people will park there only to charge their vehicles instead of having a space next to the entrance.
 - a. **Galleria Mall at Sepulveda and Ventura Boulevard** There are some stations here. Additional stations may be needed for movie times.
 - b. **Westfield Mall on upper level outside dining court** There are some stations on the bottom level. Recommend additional stations near their restaurant locations when constructed.
- 3. Grocery Stores
 - a. Ralph's at Burbank and Van Nuys Boulevard. Not sure if this Ralph's has a charger. (Ralph's on Ventura at Hazeltine does.)
 - b. New Whole Foods on Ventura Boulevard at Tyrone.
 - c. New Pavilion's on Ventura Boulevard at Kester.
 - d. Trader Joe's on Riverside at Hazeltine None there at this time.
- 4. Ventura Boulevard
 - a. Add a few pole or parking meter mounted chargers along Ventura Boulevardnear restaurants and shopping. Could have a dual meter for charging and parking fees. Spaces open to everyone.
- 5. Office Buildings Encourage owners of large office buildings to add EV chargers for employees and visitors.
 - a. Several buildings located at the corner of Sepulveda and Ventura Boulevards.
 - b. Medical and office buildings on Van Nuys Boulevard near Riverside Drive.
 - c. A few large office buildings on Riverside Drive near intersections with cross streets.
 - d. A couple along Ventura Boulevard between Sepulveda and Van Nuys Boulevard.
- 6. Schools Consider adding EV chargers at local schools for teachers, workers, and students who drive. LAUSD and private schools.
 - a. Millikan Middle School in the parking lot on the corner of Magnolia and Sunnyslope Avenue.
